1. I am a nursing student. I earned my LPN certificate in a tech school. I will tell you that I learned so very much from our lab time in that program! I have learned minimal skills in this program and cannot believe the amount of money I am paying for this! If we were able to gather in small groups to "check off/test out" on critical clinical skills, there should be a way to gather in

small groups to have at least two days in the lab to practice skills! We have zero opportunities to practice any skills before we go to a facility and have to do it with a real patient. I detest this way of learning and think it is inappropriate to expect student nurses to perform skills at clinical that we have not been able to perform even one time in a lab to practice. Why can't we meet in the lab in the same small groups where we have an opportunity to ask questions as we practice new skills?!

The College understands your frustration with the process. Please understand that we take nursing education very seriously. Most of the skills that had been taught on campus were taught in the first courses in the program, NURS 140 and NURS 141, and they would have been covered in the LPN program.

Students transitioning from LPN to RN have their skills validated, but these skills are not re-taught. Additional skills covered in later classes can be taught remotely and should have been part of the LPN clinical experience. LPNs who transition into our program are expected to validate the skills they learned, performed and tested in their LPN program.

In the following courses, these skills are being validated:

- NURS150: Wound Packing (NOT critical), concepts covered remotely (an LPN should already possess this skill)
- NURS151: Nasogastric (NG) tube insertion and removal, also documented remotely (an LPN should already possess this skill) and Intravenous Piggyback (IVPB) meds (learning concepts remotely, students come to lab for formative validation; an LPN should already possess this skill)
- NURS250: Intravenous (IV) Push through a central line (all concepts learned and practiced at bedside in NURS151 with peripheral lines, now being applied to a central line); Central Venous Catheter (CVC) dressings are being taught and documented remotely (most institutions require them to go through training when hired), so it is not necessary to do face-to-face; and the concept of sterility can be done remotely.
- NURS251: Endotracheal tube (ET)/Trach Suctioning: validated on site, and performed on real patients.

While this is not our previous normal, this is the new normal. All of our partner hiring institutions have changed their onboarding and mentorship to assure you will be on target once you are hired.

2. I am graduating in December and only my name will be shown due to a mistake; however, I have several family members who have completed the form to show their support and congratulatory messages. Will these still be shown? If so, how will I know if it is just my name being shown at the end in a list with everyone else's?
